One of the key mandates of the Nominations Committee (NC) of CES-ON is succession planning for the Board; a continual process in which the board's needs are assessed. In keeping with best practices for nonprofit boards, and indeed with evaluation best practices, the NC will be reviewing our plans and policies for addressing these needs.

In looking to CES-ON future needs, the NC will be moving our recruitment process to best align with our strategic planning; with our directions, mission, vision, and values. We will continue with our recruitment efforts to review the board's current skill set, along with the skills we will need to move forward our strategic plan. We will work with existing strengths and identify the appropriate skills and experience necessary to help us effectively operationalize the plan.

This year, the NC has a slate of 12 qualified candidates to put forward. While nominations from the floor have historically been accepted at the AGM, our recommendation at this time is to leave the 13th position open, and align our processes as described, over the coming year. We will review our recruitment and succession plans for alignment with the ISOP, and develop an integrated recruitment agenda during 2019-20 that will help us move forward our mission and vision. At the current time, the NC and Board recommend moving forward with the current slate of 12 qualified directors.
